YOUTH EMPOWERMENT

Empowering Girls to become Future STEM Stars.

ENA's youth empowerment and advocacy focus areas are now in Meru County. The focus areas heads led by the GCEO, Dr. Jennifer Riria, held an inception meeting at Kithangari Girls Secondary School; a public school located in the heart of Meru county.

The aim of the meeting was to discuss ENA's initiatives towards bridging the persistent gender gap in STEM related fields as well as addressing pertinent issues revolving around sexual reproductive health among girls.

ENA in collaboration with Kithangari Girls High school has established a steering committee who will spearhead the initiatives activities in strengthening the existing Maths and science clubs to improve performance thus boosting the overall score of the school.

The committee also plans to conduct dialogue sessions with parents, guardians and teachers for the general well-being of the students addressing issues that affect them in all aspects of live.

In doing this, ENA aims at increasing higher scores in Mathematics and Science subjects as well as reducing the percentage of teenage pregnancies in the schools.

In addition, the survey will seek to provide homegrown strategies for enhancing the voice and participation of women in the fish sector while simultaneously addressing their human rights concerns. ENA hopes to use the results of the survey to propose changes to the existing policy documents therefore entrench women as key players in the sector. The final document will also be used to inform program approaches and establish areas of collaboration between ENA and other stakeholders including the County Governments and local implementing partners in aquaculture.

WOMEN EMPOWERMENT

Aquaculture Validation Workshop on the status of Women in the Aquaculture Value Chain.

Following ENA's gender analysis survey in the fish farming sector conducted in Homa Bay county, the women empowerment focus area held a validation workshop with key project stakeholders to verify the accuracy of the findings with an objective of developing a framework for ensuring full inclusion of women in the entire fish value chain.

The validation stakeholders' forum brought together 39 participants with 27 participants representing various Government Ministries, Government Agencies and Local Civil Society Organizations and 12 media practitioners.

Among the findings highlighted during the survey, it was established that, there are no deliberate programs within the fisheries department to promote women in aquaculture. It was also noted that women tend to be few in fishing industry leadership positions. Fishing is traditionally viewed as a men's role. Other concerns by the stakeholders were that government bodies like the Ministry of Agriculture should conduct gender awareness and implement Gender-responsive fishing projects.

ENA in collaboration with other aquaculture stakeholders will continue to empower women to participate in activities designed for their empowerment, raise awareness about the dangers of fish-for-sex transactions and identify other sources of income for vulnerable women and men..

DEMOCRACY TRUST FUND

Rapid Intervention to Position Women at the Kenya National Chambers of Commerce and Industry (KNCCI).

Echo Network Africa (ENA) through the Democracy Trust Fund (DTF) initiative supported by Hanns Seidel Foundation held meetings bringing together women directors from the women in Business Forum (WIB) of the Kenya National Chamber of Commerce and Industry (KNCCI) from all the 47 counties. Following the results of the KNCCI election, not a single woman was elected as a national official. ENA began to lobby for women inclusion in the KNCCI leadership.

As a result of the engagement process, the President of KNCCI, being responsive to the challenge put across by ENA, invited the WIB National Chairperson to present 10 women, who would be co-opted into the various national committees. As a result of this development, a second meeting was convened on 12th July, 2019, bringing together the same group of women. At this meeting a vetting process was agreed upon to select the 10 women who would forwarded to the President.

The engagement process with KNCCI and specifically WIB, has demonstrated that women's voice and position in every space requires to be amplified. However, for that amplification to take place, women will need to be organized and coordinated. ENA will continue Lobbying for the amendment of the KNCCI to include the provisions that will promote women's participation as equal members in KNCCI.
