# CONSULTANCY TO TRAIN THE DEMOCRACY TRUST FUND BOARD OF TRUSTEES ON LEADERSHIP AND DEVELOPMENT

#### BACKGROUND

The Democracy Trust Fund (DTF) is an initiative of Echo Network Africa (ENA) that seeks to enhance gender inclusion by increasing the number of women leaders in all sectors of society especially Political leadership. Through targeted programmatic interventions and beneficiary participation, DTF seeks to contribute to the Sustainable Goal Number Five: Gender Equality. DTF has a vision of an inclusive society where all women are able to participate and achieve their democratic purpose. DTF's Mission: To be an equipping hub for maximum representation of women in political cycles through coaching, mentorship, training and sensitization.

As part of ENA's objective of strengthening DTF as the Local Implementing Partner (LIP) to carry outs political interventions under the Democracy and Positioning Program, DTF seeks a consultant to conduct a one (1) day training for the DTF Board of Trustees on Leadership Skills, Organizational Governance, Management & Development.

The training will be geared at improving the Board of Trustees capacities and understanding towards increased ability to make transparent, accountable, and sustainable decisions, support processes, and systems and to manage internal and external risks.

- III. To equip the DTF Board of Trustees and staff with knowledge and skills on leadership and good governance in order to provide direction, control and sustainable management of the Democracy Trust Fund.
